END-USER LICENSE AGREEMENT

IMPORTANT – READ CAREFULLY

THIS END-USER LICENSE AGREEMENT (*EULA*) IS A LEGAL AGREEMENT BETWEEN YOU (EITHER AN INDIVIDUAL OR A SINGLE ENTITY) AND DEVSOURCE LTD., A COLORADO CORPORATION (*DEVSOURCE*), FOR THE SOFTWARE PRODUCT IDENTIFIED ABOVE WHICH INCLUDES COMPUTER SOFTWARE AND ANY UPDATES THERETO, ASSOCIATED MEDIA AND PRINTED OR ELECTRONIC DOCUMENTATION (COLLECTIVELY *SOFTWARE*). BY OPENING THE SOFTWARE PACKAGING, COMPLETING THE SERIALIZATION PROCESS, CLICKING "I ACCEPT" OR DOWNLOADING, INSTALLING, ACCESSING OR UTILIZING THE SOFTWARE WHETHER ONLINE OR FROM A DISK, YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA. IF YOU DO NOT AGREE WITH THE TERMS OF THIS EULA, PROMPTLY RETURN THE UNUSED SOFTWARE TO THE PLACE FROM WHICH YOU OBTAINED IT FOR A REFUND.

1. **Ownership.** The Software is protected by copyright and other intellectual property laws and treaties. You are granted a license only to use the Software subject to the terms of this EULA but do not own the Software. IncomeMax LLC retains all title to and ownership of the Software and all copies of and modifications to the Software. The Software includes trade secrets and information that is confidential and proprietary to IncomeMax LLC and you agree to take all necessary actions to protect the confidentiality of such information.

2. **Grant and Scope of License.**
 - A. **Software.** Subject to the terms of this EULA and payment of the annual license fees, IncomeMax LLC hereby grants to you a nontransferable and nonexclusive right to install and use an executable (no source code) copy of the Software as follows: (a) a license is required for each unique individual who is authorized to use the Software; (b) the Software may be accessed only on one personal computer and on a second portable device for the exclusive use of the primary user; and (c) the Software is for your own internal use for which it was designed. For example, if you are an insurance agency with five agents who will be using the Software at any given time, then you must buy a user license for each of the five agents.

 - B. **Evaluation.** If you did not purchase a license to use the Software but were given or downloaded a copy of the Software for evaluation purposes only, then the right granted above in 2A does not apply and your use is limited to evaluating the Software for an evaluation period determined by IncomeMax LLC. For example, a 45-day period that commences upon installation of the Software. At the end of the evaluation period or earlier upon request of IncomeMax LLC, you will cease use of the Software, remove the Software from your computers and destroy all copies of the

Software. The Software may automatically disable itself at the end of the evaluation period.

3. **Restrictions.** The Software is "Not for Resale" and you may not resell or otherwise transfer for value the Software. You may not sublicense, transfer or assign your rights under this EULA without IncomeMax LLC's prior written consent. You agree not to copy the Software except for backup and disaster recovery purposes. If you make backup copies of the Software, the original copy and all backup copies may not leave your control and are owned by IncomeMax LLC. You agree not to disclose, modify, decompile, translate, disassemble or reverse engineer the Software, except and only to the extent such activity is expressly permitted by applicable law notwithstanding this limitation. You agree not to distribute, rent, lease, lend, outsource or provide commercial hosting services with the Software. You are responsible for paying all applicable taxes related to the licensing of the Software and, if necessary, will provide IncomeMax LLC written evidence of exemption.
4. **Warranty/Remedy/Limitation of Liability.** THE WARRANTY AND REMEDY SET FORTH BELOW ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES AND REMEDIES, ORAL OR WRITTEN, EXPRESSED OR IMPLIED. No IncomeMax LLC reseller, dealer, agent or employee is authorized to modify or add to the following warranties and remedies.

IncomeMax LLC warrants the Software media to be free from defects in materials under normal use for a sixty (60) day period after IncomeMax LLC delivers the Software to you. If you discover physical defects in the software media, IncomeMax LLC will, at its option, either replace the software media at no charge to you or refund the license fee paid, provided you return the Software with proof of payment to DevSource during the 60-day period after having taken delivery of the Software.

8. **General Provisions.** If any of the terms, or portions thereof, of this EULA are invalid or unenforceable under any applicable statute or rule of law, the court will reform the contract to include an enforceable term as close to the intent of the original term as possible; all other terms will remain unchanged. The waiver or failure of either party to exercise in any respect any right provided for in this EULA will not be deemed a waiver of any further or future right under this EULA. This EULA will inure to the benefit of, and is freely assignable to, IncomeMax LLC' successors and assignees of rights in the Software. This EULA is governed by and construed in accordance with the laws of State of Colorado, without regard to its conflict of law provisions, and the United States, including trademark, patent and copyright laws. The exclusive venue for all cases arising out of or related to this Agreement is the federal and state courts in the State of Colorado.
9. **Entire Agreement.** This EULA and any IncomeMax LLC purchase order constitutes the entire agreement between you and IncomeMax LLC relating to the Software, and any additions to, or modifications of, this EULA will be binding upon the parties only if the same will be in writing and duly executed by you and by a duly authorized officer of IncomeMax LLC.
